Local News: Monday July 31st, Lancaster's mayor, R Rex Parris admitted on record to donating to 5 Palmdale candidates in the past. This revelation will have lasting implications on future joint meetings between the two cities and highlights the need for a Lancaster team. The meeting, sponsored by the County of Los Angeles, is intended to further partnerships and eventually the possibility of tax sharing as part of a regionalism campaign. One project discussed is



the extension of the AV Fair through the construction of a joint recreation center in the city of Palmdale that could also serve as an evacuation center. Questions were also raised about the absence of a member or representative of Palmdale in all four of the AV Fair Boards of Trustees. The cities also discussed a plan to limit auto mall competition between them, placing a cap on the incentives cities can offer to new dealerships looking to relocate, and allowing existing dealerships to move from Lancaster to Palmdale (and vice versa), but still pay taxes to their city of origin.

The City of Palmdale gave a lengthy presentation on the work they are doing for public safety during the regular Wednesday night meeting of the city council. Many members of the public and PFC were present at Monday's meeting and vocalized their alarm at the revelation that 4 out of 5 current Palmdale council members have received donations from Lancaster's board members or their affiliates.



Rallies & Events: Sunday July 30th, AV Parents 4 Education joined in solidarity with RiseUp and Operation Underground Railroad by organizing a car rally. Over 60 decorated vehicles drove from Palmdale City Library, down 10th St West to Lancaster Blvd before returning to the Library via Sierra Highway. Slogans of "End human trafficking", 'God's Children are not for sale', and 'Save our children'" accompanied American flags for the nineteen mile trek around the valley.

Education: The Antelope Valley Parents for Education have begun partnering with other local groups around Southern California including Glendale Parents United to aid and support them in their mission to affirm parental rights in schools. Parents want to be included when deciding curriculum, topics and ideas that will be presented to their children, not shut out. Several members of AVPE witnessed firsthand the Chino Valley School Board President remove the California State Superintendent from the meeting and support the reclamation of local authority from an overreaching government body. Jessica Enos, captain for Antelope Valley Parents for Education feels this is a tipping point for California. "Local communities are telling the County and State government that enough is enough," she said. Together with parents from across Los Angeles and surrounding areas, they will be coordinating a "Parental"

Rights Rally" on Tuesday August 22, 10am at Los Angeles City Hall (Corner of 1st and Spring St). The parents have a list of demands for officials at the Los Angeles Unified School District that need to be met in order to conclude their protest. National Info: Starting August 1, 2023 in Portland Oregon Andy Ngo began his legal case against individuals and entities associated with the political organization known as Antifa. Ngo's lawyers presented the case that Ngo, a then unknown reporter, was identified, targeted, assaulted, and threatened by its members. Disruptions by individuals associated with the organization led the judge to remove attendees on day two and day four, limiting photographs to one press liaison who would share them with all news outlets on day three, and only allowing select press to attend on day five. Ngo who has gained notoriety for his reporting, alleges that in the course of his work, identified parties coordinated together in order to assault him. Tuesday, August 8, 2023, the jury who allegedly feared for their safety, and defense attorney who claimed to be Antifa aligned acquitted the individuals of all charges.

International Info: Sunday August 6, 2023, the United States was eliminated from the Women's World Cup. Starting in 1991, the American women have dominated the competition placing in the top three and winning four World Cup championship titles. Captain Megan Rapinoe has made headlines for her brightly colored hair and vocal political stances, such as kneeling for the National Anthem. The elimination of the United States by Sweden is being celebrated by some, as further proof of a "go woke, go broke" mantra that has taken the country by storm. Rapinoe failed to score a penalty kick in overtime, overshooting the goal. This is her final World Cup and has announced she will retire at the end of the 2023 season.
